

1860 Palmyra Town Meeting Minutes

At the Annual Town meeting, held at the Village Hall, in the Village of Palmyra, in and for the town of Palmyra, on the 6th day of March 1860 pursuant to adjournment

Present, presiding James Peddie, J. W. Corning, Maltby Clark Justices of the Peace

And at 8 o'clock a.m. the polls of the town Meeting were declared open by proclamation of the Justice Corning and the electors proceeded to vote

VOTED That four Constables be elected for the ensuing year

VOTED That the polls of this town meeting close a 5 o'clock P.M.

VOTED That the report of the Supervisor as made be accepted and adopted

VOTED That the report of the Highway Commissioners as read be accepted and adopted

VOTED The canvas now being completed (at 9 o'clock P.M.) and the result declared by the clerk, that we now adjourn.
