

## **1856 Palmyra Annual Town Meeting Minutes**

At the annual Town Meeting of the Town of Palmyra held pursuant to an adjournment at the Eagle Hotel kept by Wm. Doran in the Village of Palmyra on Tuesday March 4<sup>th</sup> 1856. Present presiding, Ambrose Salisbury, Jas. Peddie, J. W. Corning, Geo G. Jessup Justices of the Peace and L. D. Nims Town Clerk

VOTED That four constables be elected for the ensuing year.

VOTED That the report of the Supervisor be accepted

VOTED That the report of the commissioners of Highways be accepted

VOTED That Wm. Doran be allowed Twelve dollars for the use of his house for the present Town Meeting
