Meeting of the Palmyra, NY, Town Board was called on order of the Supervisor, January 8, 1940. Present: Sanford M. Young, Supervisor; Harold E. Jeffery, Town Clerk; Charles LeBrecht and Kingsley F. Young, Justices; Jacob W. Crookston and Joseph N. Sawyer, Councilmen.

Upon the request of Harold E. Jeffery, the Town Board appointed Helen M. Jeffery as Deputy Town Clerk with all the duties and responsibilities of the Town Clerk.

The Palmyra branch of the Union Trust Company of Rochester, NY, was designated as the depository for all town funds.

Welfare Officer Ralph H. Morhous submitted a new form of welfare questionnaire for those responsible for applicants within their family, and the same was recommended. The Welfare Officer was authorized to consult with Attorney Earl Taber and to take action where the circumstances warranted that it be done.

Supervisor Sanford M. Young gave a report of his trip to Syracuse on Friday, January 5th, 1940, concerning welfare and Civil Service problems. His per diem and expense were approved.

The following resolution was offered by Justice Young: Whereas it appears to be to the best interests of the Town of Palmyra, NY, that our method of paying our Town Clerk be changed from the per diem and fee system to the straight per diem system. Therefore be it resolved that the salary of our Town Clerk shall be on the straight per diem basis, payable at the rate of \$4.00 per day for each and every business day that the Town Clerk’s Office is open and that all fees that have heretofore been taken by the town Clerk shall be paid over to the Supervisor on or before the 15th of the month following the close of the previous month’s report. This system shall be retroactive to January 1, 1940; and

the said salary and fees be adjusted accordingly. This resolution was re-read and seconded by Councilman Sawyer and carried.

The following resolution was offered by Councilman Crookston: Resolved as of April 1, 1940, the Palmyra Town Clerk is requested to open a checking account in the Palmyra Branch of the Union Trust Company of Rochester, NY, in the names of the Palmyra, NY, Town Clerk and the Supervisor. And that on or before the 15th day of the month following the report of the preceding month's business, the Clerk shall check out to the various state and county departments the amount of fees due their department and the fees formerly accruing to the Town Clerk shall be paid over to the Supervisor for deposit in the General Town Fund. This resolution was re-read, and upon Justice Young's second was carried.

The following resolution was offered by Councilman Sawyer: Whereas on November 2, 1937, Ulysses F. Sherburne was elected as School Director for the Town of Palmyra, NY, for a term of four (4) years; and on February 23, 1938, he died thereby creating a vacancy in the office. Whereas at the bi-annual town election held on November 7, 1939, Dr. Howard R. Fisher of Palmyra, NY, was elected to fill the unexpired term of the said Ulysses W. Sherburne. Therefore be it resolved that the Palmyra, NY, Town Board hereby approves the election of the said Dr. Howard R. Fisher according to the recommendations of the State Board of Education and particularly specified in Case #3531. This resolution was re-read, and upon second by Councilman Crookston was carried.

The 1940 Highway Agreement was read, approved, and order filed. List of names of persons employed by Town superintendent was read, approved, and ordered filed.

The Supervisor read a letter received from the State Department of Archives and History, and the Town Clerk was requested to answer it.

No other business appearing, Councilman Crookston moved that the meeting stand adjourned at 3:45 p.m., was seconded by Justice Young, and upon motion carried.
