At 1 o'clock P.M. the Reports of the Supervisor and Commissioners of Highways were read and adopted. The following resolutions were then read and adopted

Resolved, That the sum of Twelve Hundred Dollars be raided by tax, for the support of the Poor of the town of Palmyra, for ensuing year

Resolved That the sum of Two Hundred Dollars be raised by tax, and paid to Darius Fuller, as compensation for damages to himself by the falling of an insecure bridge on the public highway in the eastern part of town.

Resolved That the sum of One Hundred Dollars be raised by tax to purchase books & That may be needed or required in carrying out the Compulsory Education Act.

Resolved that the supervisor be authorized to put the tools, implements, weights,

Measures etc. belonging to the office of Town Sealer in proper order expending not to exceed Twenty five Dollars therefore, the expense to be a charge against the Town and to be raised by tax upon said Town.
