

**REGULAR MEETING OF THE TOWN BOARD
PALMYRA TOWN HALL
May 26, 2022**

At 7:00 p.m., Supervisor Kenneth Miller called to order the Town Board meeting, scheduled for Thursday, May 26, 2022, at the Palmyra Town Hall, 1180 Canandaigua Rd, Palmyra, New York.

Supervisor Miller led those present in the Pledge of Allegiance to the Flag.

HEARING

GUEST SPEAKER

Mike Catalano, our representative from the Wayne County EMS Advisory board, reported that the last EMS Board meeting was cancelled because of illness, but that the county is moving forward with purchasing seven ambulances. When asked if Palmyra would use the County or Finger lakes Ambulance, the answer was ...both! This way we would always have backfill and better coverage.

1. Town Clerk Report for May:

TOWN CLERK OFFICE REPORT TO THE BOARD

MAY 2022

Besides the many, many, many requests for tax and property information (due to new assessments) this past month, we have seen an upswing in the number of marriage licenses being issued, FOIL requests, fishing licenses, and tourists stopping by for information.

I attended the Annual Town Clerk Conference in Albany April 24-27, 2022. There was a lot of valuable information shared (as usual), but especially after not meeting for two years due to COVID. There were many new laws and regulations to follow as town clerk.

Two years ago, I applied for, and received a \$500.00 scholarship to offset the cost to the Town. We were very lucky, as they were kind enough to allow me to defer it to this year!

Through dog licensing in April, we sold 62 licenses totaling \$452.00, misc sales, EZ Passes, marriage licenses, hunting/fishing, vital record requests, code enforcement and escrow deposits, etc- added an additional \$4,756.20. Total check disbursements for the month of April were \$5,208.20.

As tax collector as well as town clerk, I would like to thank all the county supervisors for listening to our concerns and pulling a resolution that would have allowed the county to print and mail tax bills off site. By not allowing us to sort the tax bills locally first before mailing, we would not be able to serve our community properly. This would have caused much confusion to the taxpayers, mortgage companies, and new home owners, as well as cost additional time and money solving these issues.

2. Building Update: Councilman Cook has a call into Brad Jacobs to repair the south sidewalk and is waiting to hear how much it will cost, and when they would be able to fit us in their schedule. He has also called the Helper Brothers to schedule gutter cleaning, mulch and weeding. They should be here in the next couple weeks. Also, Highway Superintendent Boesel is getting a quote for the town to pave part of the parking lot at the town hall.

1. Highway Superintendent Report for May:

HIGHWAY SUPERINTENDENT REPORT

Since the 4/28/22 meeting we have completed the following work:

- Hauling Stone for road projects
- Brush mowing – Parker Road, Leroy Road, Hanagan Road
- **Palmyra Municipal Auction** – May 14th we held our Annual Palmyra Municipal Auction. (37th year?) The Auction was noticeably smaller and completely held in the rear of our facility with nothing out front. Total sales were just over \$1.0 Million (down from \$2M), 213 Lots (down from 358), 271 registered onsite bidders (down from 414) plus 1575 approved online bidders (up from 1561). Wayne County Sales Tax generated was \$17,230.84. We also did well with the sale of our 2020 Kubota zero-turn (\$6300), old Western plow (\$1200), pallet of fans (\$85.00), old stainless-steel salter (\$50.00).
- **Winter Recap/Salt** – We ended the winter season with 92 trips out of the barn. We utilized approximately 2208 tons of our 2600-ton allotment, which is approximately 85% of our requested allotment. My new salt allotment was due on 4/30/22 and I kept our allotment the same at 2600 tons for 2022-23. We still have approximately \$38K unexpended to use for the remainder of the Town fiscal year, which would get us ~675 tons to help refill the barns.

- **Personnel** – Chris Bratt started back mowing with us on 5/12/22. He has currently mowed most of our Town Roads and will next start mowing County Highways before starting a 2nd pass in the Town.
- **New Equipment!** – – Our new 2022 18,000lb PJ tilt-deck trailer arrived on 5/13/22. Our old 2013 14,000lb PJ trailer was purchased by the Village of Palmyra. I understand our new mini-excavator has been shipped from the Midwest and I expect to see it soon. Thank you for this new equipment!!!
- **Upcoming Road Projects** – With the Auction behind us, we have started gearing up for our various summer road projects. We are already near completion on a joint re-paving project on Parker Road, north of Cole Road, with the Town of Marion Hwy. We are inching closer to starting our Bear Hill/Rolfe project and we intend to be on several roads this summer including but not limited to Cambier, Omeal, Eckert, Hazen, Hogback, Vault and a few others.
- **Truck Barn Heat Project** –Schiller Corp and MicroClimate reps completed installation of our new waste oil boiler system and in-floor heat and fired-up the unit on Friday May 13th. It will remain off until the Fall. We have a 1-year service contract with Schiller built into the job along with 1-year parts/labor. Thank you for this project!

Any questions, comments or concerns I will be glad to answer.

Mr. Boesel also reported that there will be a WC Rabies Clinic at the Highway Barn on June 4th, from 10 AM – Noon. The guys have been helping set up for the huge concert in the village this coming weekend with barricades, no parking signs, etc. He also reported that the auction took in ½ in sales then the \$2 Million it took in last year, fuel costs are higher than they have ever been, and that they will only make the three trips on county roads that they are paid for.

Lastly, Councilman Pipitone asked how long the Foster St. project will take? Mr. Boesel said it will be done before school begins, and as everything right now, there are delays in receiving the pipes.

Town Development: IT & Phones, Fire Protection Contracts, and Strategic Plans

1. Update on East Palmyra Fire Contract: Mr. DeRue has begun negotiations with the E. Pal Fire Department, and it looks like it will be a two-year contract, putting us on back on track with the other departments. The next step is to check with insurance to get the final numbers in place.
