Welfare Officer Ralph H. Morhous appeared before the Board and stated that he did not think the salary of \$75 per month fixed for him by a resolution of the Board on april 21, 1933, was sufficient remuneration for the work of the office, especially during the period that work relief was in progress. He asked the Board if they could arrange for an increase in his salary. The matter was taken up and discussed at length and the facts thoroughly investigated. After due consideration, the following resolution offered by J. N. Sawyer, seconded by L. c. Ziegler was adopted. Harry E. Williamson not voting:

Resolved that the salary of the Welfare Officer be set at \$100 (One Hundred Dollars) per month during the period that work relief is in progress, commencing as of May 1st, 1933. At the completion of the projects to return to the resolution adopted April 21, 1933, fixing the salary at 475 per month. The Welfare Officer is also to receive mileage on cases taken to hospitals at the rate of five cents per mile.

The health of the town has been good. The welfare work has been well administered. The milk situation has added to the duties of the Health Officer. We think that the worst may be over.
