

NOTICE OF PUBLIC HEARING
UPON PRELIMINARY BUDGET
FOR CALENDAR YEAR 2000

The legal notice, as published in the Courier-Journal, was read by Beverly E. Hickman, Town Clerk.

Supervisor Lyon asked those present if there were any questions or comments regarding this preliminary budget.

Marv Garland – A question under Zoning – 8018.100 – Infrastructure Construction – What is it? Supervisor Lyon explained that the CEO was now required to do some of the inspections on certain infrastructure construction projects. Mr. Garland asked if this money gets added to the CEO's salary. Supervisor Lyon told him that it does-there is a agreement between the Town and the Village to cover this for two years. Mr. Grier explained the savings to the taxpayers by doing the inspections this way.
