

1936 Town of Palmyra Minutes

Regular meeting of the Palmyra Town Board was held at the Town Clerk's Office on Friday evening, January 10, 1936. Present: Sanford M. Young, Supervisor; Joseph N. Sawyer, Kingsley F. Young, Jacob Crookston, and Louis C. Ziegler, Justices; and Harry E. Williamson, Clerk. The meeting was called to order by Supervisor Young, and the minutes of the last meeting were read and approved.

Ralph H. Morhous' salary and expense in the amount of \$112.75 was audited and ordered paid.

The following resolution was duly adopted: Resolved that the Wayne County Trust Company is the depository of all town funds.

The following resolution was duly adopted: Whereas the Wayne County Board of Supervisors by its resolution adopted on the 17th day of December, 1935, adopted the plan provided by Section 50, sub 3A of the Workmen's Compensation Law for mutual self-insurance on the assessment plan of Wayne County and of such villages and towns therein as by resolution of their governing boards elect to participate for the payment of compensation under the Workmen's Compensation Law to the employees of Wayne county and the several participating municipal corporations, including volunteer firemen to the limits as fixed by Section 205 of the General Municipal Law. Now therefore this Palmyra Town Board, a municipal corporation within Wayne County hereby elects for and on behalf of the Town of Palmyra, that said town participate in said plan for mutual self-insurance on the assessment plan in accordance with said resolution of the Wayne county Board of Supervisor, and in accordance with the provisions of Sections 50, sub 3A of the Workmen's Compensation Law. And it is further resolved that the Palmyra Town Clerk transmit a certified copy of this resolution to the Wayne County Board of Supervisors Clerk, Lyons, NY, and the State Industrial Commissioner, Albany, NY.

On motion of Mr. Ziegler, seconded by Mr. Kingsley F. Young and duly carried, Supervisor Young was instructed to cancel Workmen's Compensation Insurance No. 6613279 with S. E. Braman Agency.

Moved that Superintendent of Highways DeBrine be authorized to attend the National Machinery Show held in Cleveland, Ohio.

A motion, duly made and carried that Supervisor Young, Town Clerk Harry E. Williamson, and Town Superintendent of Highways DeBrine be authorized to attend the meeting of towns to be held in Albany on February 26 and 27.

Special meeting of the Palmyra Town Board was held in the Town Clerk's Office on Friday evening, September 22, 1936, at 7:30. Present: Sanford M. Young, Supervisor;

Jacob Crookston, Joseph N. Sawyer, Louis C. Ziegler, and Kingsley F. Young, Justices. Meeting was called to order by Supervisor Young, and the minutes of the last meeting were read and approved.

The bill of Merle A. Dickinson for \$50.06 was audited and ordered paid.

The Town Clerk reported that some weeks since he had received a petition and papers from a representative of the Central Greyhound Lines, Inc. of NY, praying for a permit to operate their lines; and which through error asked for a permit to cover State Route 31 from the eastern boundary line to the western margin of the Town of Palmyra, which would take same in part through Ontario County and in part through the Village of Palmyra. The matter was referred to George S. Tinklepaugh of Palmyra, NY, as attorney. Pursuant to negotiations had by him with a representative of the Greyhound Lines, a new or amended petition had been filed asking for consent for the bus route to travel that part of the State Highway 31 running through the Town of Palmyra between the eastern boundary of the Town of Palmyra and the eastern boundary of the village of Palmyra.

On motion of Mr. Ziegler, the petition was ordered received and filed.

George S. Tinklepaugh, attorney, then advised the Board generally as to their rights and powers in the matter; and the following preamble and resolution was then offered by Mr. Kingsley F. Young, duly seconded and unanimously adopted: Whereas Central Greyhound Lines, Inc. of NY has this day filed with this Board a petition praying for the consent of the local authorities of the Town of Palmyra to the operation of an omnibus line upon certain roads in said petition described and referred to; now therefore be it resolved that the said petition be received and that a public hearing thereupon as provided by law be held at the Palmyra Town Clerk's Office in the Union Trust Company Bank of Rochester for its Palmyra Branch and situated in the Village and Township of Palmyra, NY, on Tuesday, October 13, 1936, at 2 o'clock p.m., at which time all persons interested in said matter shall be given an opportunity to be heard. And be it further resolved that notice of said public hearing be given by publishing a notice thereof at least once in each week for two consecutive weeks in the Palmyra Courier Journal, a weekly newspaper published in the Township of Palmyra, NY, the first publication to be made not later than September 24, 1936.

A general discussion was then had on the subject of said petition, and George S. Tinklepaugh, employed as attorney by the town for such purpose outlined generally to the board the provisions and conditions of the former franchise granted to Greyhound Lines. After the members of the board had expressed various opinions upon the subject, the attorney was directed to prepare a proposed franchise along the general lines discussed at this meeting and present it to the board at the time and place at which the hearing was to be held.

On motion duly made and seconded, it was further resolved that a regular meeting of this board be held at the time and place above named for the public hearing above referred to at which time further action would be taken upon said application.

Petition of Greyhound Lines follows: In the matter of the application of Central Greyhound Lines, Inc. of NY, for the consent of the local authorities of the Town of Palmyra, NY, for the operation of an omnibus line upon and over certain roads, streets, or avenues of the said Town of Palmyra, NY. The petitioner, Central Greyhound Lines, Inc. of NY, respectively alleges as follows: First: That your petitioner is, and at all times hereinafter mentioned, was a corporation organized under and pursuant to the Transportation Corporation Law of the State of NY.

Second: That in the event that consent of the local authorities of the Town of Palmyra shall be granted to your petitioner, your petitioner alleges that it will obey all laws and ordinances of said Town of Palmyra and all laws of the State of NY and elsewhere, and will operate said omnibus line so as to comply with all laws and all rules and regulations pertaining thereto.

Wherefore your petitioner prays that the consent of the local authorities of the said town of Palmyra be granted to your petitioner for the operation of an omnibus line along and over certain roads, streets, or avenues of said Town of Palmyra along the following route; viz., commencing at the easterly margin of the Town of Palmyra, State Highway Route 31 and continuing along said State Highway 31 over such sections of the said State Highway 31 as passes though the Township of Palmyra to the eastern boundary line of the village of Palmyra and returning over the same route. And which said consent shall permit the said petitioner to extend the operation of said omnibus line to any point within the State of NY. And your petitioner further prays that a public hearing be held by said local authorities of the said Town of Palmyra, of which due and proper notice shall be given by law.

F. P. Wadler, Regional Manager for the Central Greyhound Lines, Inc., was present at the meeting as representative of the Greyhound Company in their application to the Town Board for a franchise.

The Clerk then read the notice ordered to be published at the meeting of this Board held on September 22nd, 1936, together with proof of publication showing that same had been duly published for two consecutive weeks in the Palmyra Courier Journal, a newspaper published in the Village and Town of Palmyra. He stated that the bill of the Palmyra Courier Company for publishing such notice had been presented in the sum of \$4.95.

After listening to the arguments of the parties present, Mr. George S. Tinklepaugh, Attorney for the Town, then presented a proposed form of franchise and consent granting to the Central Greyhound Lines, Inc. of NY, consent or permission to operate its motor vehicle line in accordance with the petition filed. He reported that it was drawn in harmony with the thoughts heretofore expressed to him by members of the Board and along the lines which he had been advised would be satisfactory to the petitioner. By Direction of the Supervisor, the proposed franchise was considered judgment of the Board that it was in compliance with the general discussion held at the last meeting of the Board and contained the general provisions desire by the Board.

The following resolution was offered by Kingsley F. Young: Whereas Central Greyhound Lines, Inc. of NY did heretofore file with the Palmyra Town Board (the Town Board being the local authority of said Town of Palmyra) a verified petition in writing for

consent or permission of the said local authority of the said Town of Palmyra to establish and operate a motor vehicle line or route upon and along the highways, streets, or avenues of the said Town of Palmyra in the County of Wayne, State of NY, along the following route, viz: Commencing at the eastern margin of the Town of Palmyra, NY, on State Highway Route 31 and continuing along said State Highway 31 over such section of said State Highway as passes through the Township of Palmyra, westerly to the eastern boundary line of the Village of Palmyra and returning over the same route for the transportation of persons and property for compensation. And whereas the said Palmyra Town Board did upon the September 22nd, 1936, receive said petition and place same on file and did thereafter by resolution duly adopted, ordered, and direct that a public hearing upon said petition be held as required by law at the Palmyra Town Clerk's Office located in the Union Trust Bank Building of Rochester for its Palmyra Branch situated in the Village and Township of Palmyra on Tuesday, October 13th, 1936, at 2 o'clock p.m.

And whereas due notice of said hearing was given as required by law and proof thereof. The publication of said notice was filed with the Palmyra Town Clerk. Public hearing having been held at the time and place designated, and all persons present having had an opportunity to be heard. Said hearing having been closed, and the said Palmyra Town Board being of the opinion that such motor vehicle line or route herein referred to is of benefit to the Town of Palmyra and to the residents thereof and will also serve a public necessity and be for public convenience.

Now therefore be it resolved that this Town Board grant and issue, and it does hereby grant and issue to the said Central Greyhound Lines, Inc. of NY consent or permission to operate motor vehicle for the transportation of persons and property for compensation upon and along the following highways, streets, and avenues of said Town of Palmyra, viz: Commencing at the eastern margin of the Town of Palmyra, NY on State Highway Route No. 31 and continuing along said State Highway No. 31 over such sections of said State Highway No. 31 as passes through the Township of Palmyra westerly to the eastern boundary line of the Village of Palmyra and returning over same route.

Subject nevertheless to and upon the following and hereinafter set forth covenants, agreements, terms, conditions, and reservations, all of which are to be construed as being by way of extension and not construed as in any manner in limitation of rights which the Town of Palmyra would otherwise have by any law or statute now or hereafter applicable to the premises.

The covenants, agreements, terms, conditions, and reservations above referred to are as follows:

1. That the said Central Greyhound Lines, Inc. of NY and its successors shall provide motor vehicles sufficient in capacity and number to reasonably accommodate the traveling public in and out of said Town of Palmyra and along the said motor vehicle line or route.

2. That the operation of said motor vehicle line or route and the motor vehicle operated thereon pursuant to this consent shall at all times be subject to such rules, regulations, ordinances, and conditions as are now in force in said Town of Palmyra, NY, or that said Town through its duly constituted officials, boards, or departments may hereafter or from time to time lawfully prescribe, and that said Central Greyhound Lines, Inc. of NY, and its successors in interest, shall at all times comply therewith together with all provisions of the laws of the State of NY applicable hereto.
3. That the said Central Greyhound Lines, Inc. of NY and its successors in interest shall obey and observe each and every condition of this consent to its full intent and meaning.
4. That the said Central Greyhound Lines, Inc. of NY shall comply with all rules and regulations of the Public Service Commission of NY.
5. That the said Central Greyhound Lines, Inc. of NY and its successors in interest shall promptly pay to the Town of Palmyra for any damages to its highways, guard rails, or bridges occasioned by the said Central Greyhound Lines, Inc. of NY, its agents, servants, employees, or successors in interest which shall occur by reason of the granting of this consent—ordinary wear and tear excepted.
6. That in the event any damages shall be caused to the said Town of Palmyra of any kind, name, or nature in addition to damages to the highway, guard rails, or bridges as hereinabove provided by reason of any neglect or fault of the said Central Greyhound Lines, Inc. of NY or its agents, servants, or employees, and successors in interest. The said Central Greyhound Lines, Inc. of NY or its successors in interest shall compensate the said Town of Palmyra to the amount and to the extent of such damages and expenses in connection therewith and shall save the said Town of Palmyra harmless on account thereof.
7. That the said Central Greyhound Lines, Inc. of NY shall make all reasonable effort to maintain and operate said motor vehicle line or route in all season of the year.
8. That should vehicular traffic be diverted from all or any part of the highway forming the route herein specified for any reason whatsoever should such highway or any part thereof be closed temporarily to vehicular traffic, which right to close such highway temporarily to vehicular traffic is not to be impaired by this consent. The grantee herein during such time that such vehicular traffic may be diverted or during the time of such temporary closing of any such highway may use such other highways in said Town as may be necessary for the operation of said line or route but only as directed by the proper authorities having charge of streets and highways and the traffic thereupon.

9. That in consideration of the granting of this consent said grantee hereby waives and releases the Town of Palmyra, its officers, officials, agents, and employees of and from each and every claim which it might except for this waiver and release be permitted by law to make against it, him, or them by reason of any act or omission of any officer, official, agent, or employee of said Town, particularly as to removal of snow and ice, an generally as to omission to perform any duty which it might be claimed was by law imposed upon said town, its officers, officials, agents, and employees as to care and maintenance of said highway and land adjacent thereto under its jurisdiction.
10. That the grantee in consideration of the granting of this consent and by the acceptance of , and, or operation under this consent or franchise assumes; and it hereby does assume and agree with the town of Palmyra that it will protect and indemnify that said Town of Palmyra, its officers, officials, agents, and employees of an from all claims and demands suffered or claimed to have been suffered by any person and/or persons, co-partnership, corporation, or otherwise by reason of any act, matter, or thing claimed to have been caused by or claimed to have resulted from the operation or maintenance of motor vehicle authorized to be operated within the town of Palmyra by virtue of this consent and to protect and defend in the name and on behalf of the said Town of Palmyra, its officers, officials, agents, and employees but at its own expense, any suit or suits, action, or actions at law brought in which the Town of Palmyra or any of such parties shall be named as defendant, claiming damages by reason of any injury either to person or property or otherwise claimed to have been suffered by reason or in connections with the operation of said motor vehicle route over and through streets and highways of the Town of Palmyra where claim is made that said Town of any of its officers, officials, agents, or employees have in any way either by affirmative or negligent act or acts or omission of duty upon its, his, or their part, in any way contributed or been a party to the cause of such damages, and will assume, make its own and pay each and every judgment or claim which shall be sustained against the said town or any of such parties upon any of the grounds hereinbefore stated with all costs or interest which may accrue, and otherwise to the end that no expense shall at any time hereafter be caused to the town or any or such parties or the said Town or any such parties obliged to defend any litigation or ay any claims, demands, judgments, or expenses in connection therewith which shall have been caused or claimed to have been caused by any affirmative act or any alleged or actual negligence, omission of duty or otherwise on the part of either the grantee or the said Town or any of its officers, officials, agents, or employee and occasioned through the medium of the operation of motor vehicle pursuant to this consent.
11. That the grantee for said consideration does also covenant and agree to and with the said Town of Palmyra and by the acceptance of any or operation under this franchise does covenant and agree that it will make no claim for damages of any kind by reason of any or omission on the part of the Town of Palmyra, its officers, officials, agents, and/or employees for or by reason of which it otherwise might make claim for damages claimed to have been suffered by it

while operating under this franchise. It further covenants and agrees generally to protect and indemnify the town of Palmyra, its officers, officials, agents, and/or employees of and from all costs, damages, expenses, and liability which may hereafter be incurred by the Town, its officers, officials, agents, and/or employees in favor of any person or party claimed to have been sustained by or in connection with or resulting from the operation of or riding as a passenger in the omnibuses or vehicles of the grantee over any of the streets and/or highways, and/or public places in the Town of Palmyra.

12. This permission and consent to operate a motor vehicle line over the hereinbefore described route is grants and is to be used by the grantee, jointly with other lawful users of the said highways and streets and shall not be construed as in any way limiting or restricting the rights of said Town of Palmyra to grant other or similar rights to other persons, firms, or corporations for the operation of motor vehicles over and upon the highway above described.
13. All terms, conditions, reservations, and restrictions herein contained are to be construed as extending and not as limiting the rights and powers of the said Town of Palmyra and shall not be construed as in any way limiting or restricting any rights or privileges which now are or hereafter may be given by any law or statute of towns upon the subject of transportation corporations.
14. That this consent may be revoked for cause after a hearing and after ten days notice in writing thereof to be given to the said Central Greyhound Lines, Inc. of NY, and such notice may be given by mailing a copy thereof addressed to the said Central Greyhound Lines, Inc. of NY at its last known place of business.
15. That the said Central Greyhound Lines, Inc. of NY shall pay to the said Town of Palmyra the sum of \$4.25 to reimburse it for the cost of publishing the notice of the holding of the public hearing in connection with the granting of this consent.

Be it further resolved that the Palmyra Town Clerk be, and he hereby is authorized and directed to execute and deliver to said Central Greyhound Lines, Inc. of NY upon demand therefore a copy of this formal consent in writing acknowledged or proved as are deeds entitled to be recorded, containing the consent or permission herein granted. The terms and conditions in this resolution state, but the adoption of this resolution shall be deemed to be the granting of said consent and may be evidenced by a certified copy thereof and the execution and delivery of said formal consent in writing shall only be as, when, and if desired by said Central Greyhound Lines, Inc. of NY, and which provision is made for the purpose of permitting the said Central Greyhound Lines, Inc. of NY, to obtain and record a public record thereof provided, however, that if in addition to a certified copy hereof, grantee shall require a further copy acknowledge or proved as deeds are entitled to be recorded as above specified. Same shall only be furnished upon the grantee paying the reasonable charge for the preparation and execution thereof.

Be it further resolved that said local authority hereby gives consent to the Central Greyhounds Lines, Inc. of NY to extend the operation of said omnibus line to any point within the State of NY upon said grantee procuring other necessary consents therefor.

The foregoing resolution was duly seconded by Joseph N. Sawyer, and a vote thereupon duly taken and recorded as follows: For the resolution: Sanford M. Young, Louis C. Ziegler, Joseph N. Sawyer, Kingsley F. Young, and Jacob Crookston. Opposed: None

Whereupon the resolution was declared to be duly carried and adopted.
