Five Hundred Dollars for the Highway fund and Two Hundred Dollars for Soldiers Relief and it was further recommended that the Clerk procure the necessary names and hold a special Town meeting on the 20th day of March 1900.

Mr. H. P. Knowles presented the report of the Soldiers Relief Fund which was found correct and had been satisfactorily expended.

The Dog fund was examined and found to be correct the amount \$207.00 which had been transferred by resolution of the Board on Nov 13 to the Highway fund. Balanced the same

The report of the General fund was examined with vouchers attached and the same was found correct showing a balance on hand of \$833.58

On motion C. A. Marshall and J. W. Phelps were appointed Poll Clerks and Isaac Jeffrey and L. S. Travers were appointed Ballot Clerk for the special election to be held, March 20th 1900.
