REGULAR MEETING OF THE TOWN BOARD

PALMYRA TOWN HALL AUGUST 27, 2009

At 7:36 p.m., Supervisor Lyon called to order the assembled group of about 150 residents for a public informational presentation on the Farmland Protection Grant Program.

Property owners of 7 acres of land or larger had received letters from Supervisor Lyon inviting them to listen to the presentation. Ora Rothfuss—Wayne County Agricultural Specialist—stated he would explain what Farmland Protection is, what it means to individual property owners, and what Federal and State grants are available. He described the program as a Land Use Planning Tool. It works with the current zoning laws, based on the town's Comprehensive Plan.

By having the State, the local municipality, or a Land Trust purchase easements on these agricultural lands, development rights are extinguished. Sometimes, mining rights are extinguished also.

In addition, part of the plan includes conservation—treatment of soil—and forest management. Grant sources include Environmental Protection (EPA) funds, as well as other farm land, parks, historic places, etc. grants. Rothfuss said the plan works best if the Town is the lead applicant. At best, the process is slow, with the usual time frame around 3 years. Many documents are needed to complete the process, including easements, surveys, title insurance, stewardship fees, etc. Only two farmers per Town per year are accepted. The least amount of acreage included in the program is 40 acres, while most successful farms for grant money are at least 100 acres.

The State program is extremely competitive, so it would mean looking to put together viable programs.

One question that was asked was why Palmyra landowners who own 7 acres or more were invited to the meeting, if such large acreage is required. Supervisor Lyon explained that the Town Board was not aware of the parameters of these grant programs before the meeting. In addition, he said that if people wanted to participate—perhaps in conjunction with another farmer—we didn't want to leave them out of the presentation of information.

Dave Lyon asked what the next step is for us. Rothfuss said we need to see if anyone comes forward. If so, the process can start in January.
