Supervisor Lyon announced the hearing was being held for the public to address the Board regarding the proposed fire protection contract between the Town of Palmyra and the Village of Palmyra. Mr. Lyon asked Mayor Daly if she had any questions regarding the proposed contract. She replied that she knew Councilman Lambrix and Village Trustee Mark Palmer had met and negotiated a contract, and suggested Mr. Lambrix could explain the proposal.

Mr. Lambrix announced he and Mr. Palmer had agreed to a two year contract with the amount for the first year, 2003, to be \$55,000 and the second year, 2004, to be \$57,750.

Supervisor Lyon asked Fire Chief Warren Frederick what he thought of the proposed contract; Mr. Frederick replied that it sounded good to him. Fire Company Director Ronald Hickman agreed.

Supervisor Lyon asked if there were any other questions or comments regarding the proposed Fire Protection contract between the Town of Palmyra and the Village of Palmyra for 2003-2004. There being none, Supervisor Lyon declared the hearing closed at 7:35 PM.
